Stock transfers often arrive without donor information. Please notify the Development Office so we can provide proper acknowledgement.
- **Qualified Charitable Distributions (QCDs):** If you are 70-1/2 years old or older, you can direct up to \$100,000 per year from your Individual Retirement Account (IRA) to a qualified nonprofit like the Songbook Foundation without having to include the distribution in your taxable income. This is an excellent way to fulfill your minimum distribution requirement while simultaneously supporting our mission.
- **Grants from Donor-Advised Funds (DAFs):** If you have a donor-advised fund, you can recommend a grant to the Songbook Foundation.
- **Planned Gifts:** Ensuring future generations have access to the performing arts can be a part of your legacy.
